

## **Privacy Policy**

Our website, other company websites, widgets, mobile applications, and other platforms (collectively referred to as the "Site") are how we gather personal data. This privacy statement covers both domestic and foreign data protection legislation as well as any personal information we may get during the course of providing our services about any authorised representatives of the Client. We get and gather the data you voluntarily give to us. When you sign up for an account with us, take part in any interactive elements of our services, make a purchase, request help or customer support, or communicate with us through our site or third-party platforms and sites, we may collect information from you.

Your name, email address, and phone number are just a few of the essential details that we will gather if you register for an account or other services with us. The suitability and appropriateness of the services we provide to you may be assessed using this data. Additionally, we gather data about your device, including the mobile network identity, the type of browser and mobile device you use. Additionally, if you allow your location settings to be enabled on your device, we may be able to gather information from your device, including its specific position.

On our website, we keep track of all user activity, including any posted content, logged account information, and transaction details, such as the sum and currency of deposits and withdrawals. You agree that we employ "Cookies" and other software, such web beacons, that systematically gather data. When you visit our site, your browser receives a small amount of data called a cookie that is stored there and helps us improve our services as well as your usage and experience. Additionally, it allows us to determine which regions and features of our services receive the most visitors overall and are the most frequently used.

In order to maintain and enhance the services we have for you, we may use the information we have obtained from you. In addition to administering and verifying your account, we may use this information to ensure that we are meeting all of our legal and regulatory duties. The information you supply also enables us to keep an eye on any posts and actions, including any potential misuse of our services and the detection of criminal activity. You acknowledge and agree that the data we gather on you may also be used as evidence in court orders, investigations, and legal procedures.

You consent to our using the data as a reference in the event of complaints and the resolution of disputes. Regarding the disclosure of information, we only share collected data with the Company, its subsidiaries, and affiliates, including our service providers and financial institutions, for business purposes. You accept that in line with or as required by any applicable legislation or legal process, we may also share your information in response to a request for information. To meet criteria for law enforcement or national security, this also includes legitimate requests made by public authorities.
